#### **Saving our Species Partnership Grants**

Funded by the <u>NSW Environmental Trust</u>, the SoS partnership Grants program encourages partnerships between government, the community, non-government organisations and corporations to protect and conserve our most vulnerable plants and animals in NSW.



Round 2 focuses on projects targeting landscape-managed species, as identified under the SoS Program. The program is specifically designed to encourage stakeholder to join forces to help protect and conserve threatened species and applicants must form stakeholder partnerships operating as a coordinated consortium.

Individual grants of between \$300,000 and \$1,000,000 are available over 6 years, including seed funding

for successful EOI applicants to develop a detailed project Business Plan. More funding and application criteria are available on the OEH website at:

The closing date is the 28th September 2015.



#### 20 Million Trees Programme Grant Round 2





Round Two of the 20 Million Trees Programme invites applications from individuals, organisations and community groups such as

schools, landholders and conservation groups to apply for funding of between \$20,000 and \$100,000 to plant trees in a range of urban, peri-urban and regional environments across Australia.

The Programme will support projects that involve the community in re-establishing native vegetation, provide habitat to support our threatened species, sequester carbon from the atmosphere and help to create greener spaces to improve the liveability of Australia's cities and towns. Priority for Round Two will be given to projects with positive outcomes for threatened species and threatened ecological communities listed under the EPBC Act.

### **Environmental Restoration and Rehabilitation Grants**





Applications are now invited for the next round of the Environmental Trusts Restoration and Rehabilitation grants program.

The aim of the Restoration and Rehabilitation program is to facilitate projects run by community organisations and government entities working to prevent or reduce environmental degradation and pollution, restore habitats and improve the capacity of the community to protect important ecosystems and species. #### **Habitat Action Grants**

Angling clubs, individuals, community groups, local councils and organisations interested in rehabilitating fish habitats in freshwater and saltwater areas throughout NSW can apply for grants.



Habitat rehabilitation projects which may be funded include:

- removal or modification of barriers to fish passage
- rehabilitation of riparian lands (river banks, wetlands, mangrove forests, saltmarsh)
- re-snagging waterways with timber structure
- removal of exotic vegetation from waterways
- bank stabilisation works
- reinstatement of natural flow regimes

Applications will close at 5 pm Friday 16 October 2015.





### Fauna Protection & Pest Animal Control

#### Invitation to Participate

North Coast Local Land Services, in partnership with Byron Shire Council and NSW National Parks and Wildlife Service (NPWS) is coordinating the implementation of a Pest Animal control project to protect native fauna in priority locations within the Byron Shire. The project aims to enhance the control of foxes, wild dogs and potentially cats.

The project area covers the West Byron Sewerage Treatment Plant and wetlands, Tyagarah Nature Reserve and Brunswick Nature Reserve. In addition, there is the opportunity to increase the area of Pest Animal control onto privately managed land adjacent to these existing areas of control. These activities on your property will compliment and benefit existing control activities in the area.

Your participation in the project will positively impact on threatened native species including the Potoroo, Koala and several species of water, bush and shore birds that inhabit Byron Shire. You are invited to a public information meeting to learn more about the project, including:

- Becoming involved in the project
- Its goals and objectives
- Pest animal control methods
- Protection of native fauna
- Why the project is important

#### Current Management of Pest Animals

#### NSW National Parks & Wildlife Service

The NPWS undertakes control programs in accordance with its Wild Dog Policy. The process for developing and implementing a wild dog program is:

- Determine the presence or absence of wild dogs by using sand pad transects or camera traps in areas where wild dogs are thought to be a problem and monitor these for consecutive days.
- Where presence has been confirmed conduct 1080 baiting in the identified area by establishing bait stations and monitoring these in accordance with Schedule 2 of the 1080 Pesticide Control Order, for a period of three to six weeks (or longer if required).
- Reassess the presence or absence of wild dogs in the identified area after baiting using sand pad transects or cameras and monitor for consecutive days.
- Repeat steps in Spring and Autumn of each year.

NPWS encourages its neighbours to join in with their control programs to increase the effectiveness of the program. Advertisements are placed in local newspapers identifying the dates and the locations of any baiting programs and contact numbers for more information.

# Trees of Significance for Traditional Owners, Biodiversity and the Community

Friday October 30th – 8:30am to 4:30pm Room B1: 21/22, Wollongbar TAFE

This workshop will explore the values that veteran scar trees play in the landscape and how these trees can be protected and managed alongside other uses of the land.

#### Speakers include:

- Traditional Owners who will discuss what is a scarred tree; what this can mean to them and cultural reasons for protecting these trees.
- The Veteran Tree Group Australia who will cover the value of very old (veteran) trees for biodiversity and how to protect and manage them in varied landscapes.



## **Draft NSW Invasive Species Plan on exhibition** now

A review of the NSW Invasive Species Plan 2008-15 was recently undertaken to ensure invasive species in NSW continues to be managed by objective and successful programs.

An updated NSW Invasive Species Plan 2015-22 has now been drafted by NSW Department of Primary Industries (DPI) in collaboration with public land managers (Local Land Services, Crown Lands and NSW National Parks and Wildlife Service), and is open for public consultation.

Landholder and community feedback is sought to ensure priorities have been appropriately identified and to also help guide future investment in invasive species management. Following the consultation process all comments received will be reviewed and considered for incorporation into the final plan.

# Far North Coast Weeds

Koster's curse (*Clidemia hirta*) is a class 1 noxious weed in the Far North Coast region.

First found in Australia at a nursery in North Queensland, it is suspected to have entered as a contaminant of packaging material.



With a wide native range extending from Mexico through Costa Rica, to Argentina and the West Indies, it has never been detected in NSW.

A highly invasive shrub, growing up to 5m tall, it forms dense thickets that can smother pasture and native vegetation in a similar manner to Lantana, and could cause major problems for primary industries. It will invade disturbed areas, including the edges of clearings and stream-banks, along fence lines, paths and roadways.

Leaves are normally 8-10cm long, oppositely arranged, and hairier on the under surface with clusters of 6-20 small white flowers.

Reproduction is by seed and each plant has the potential to produce 500 berries a year, each containing up to 900 seeds, which can persist in the soil for at least four years.

The most common method of dispersal is via birds that eat the berries, but the fruit may also be spread by water and human intervention.

#### Plant of the Month

This months plant of the month is Variegated Arrowhead Vine *Syngonium podophyllum*.

It is an evergreen, climbing plant with great variations in leaf colour and shape depending on the variety. In general, leaves are arrowhead-shaped and glossy. The





inflorescence (flower-bearing part) comprises 6 - 9 green tubular-oblong flowers. It smothers native

groundcover and seedlings and can climb up trees. It is a common indoor plant and can also be found in many suburban gardens but when in bushland forms dense strangling masses

on vine. This vine only spreads vegetatively so is mainly spread into bushland by garden waste dumping.
